NRLN Update

Support NRLN Lobbying efforts. Go to <u>www.nrln.org</u> to respond to Action Alerts on the following 6 issues which are important to our health and well-being. There is a short explanation of what each of these represents and how important it is for you to contact your Congressional Representatives. An Action Alert has a pre-written message and links you with your Congressional Representatives. All you do is enter your zip code and Click. This important action will take you no more than 5 minutes. They are:

Rectify Injustice to Delphi Salaried Retirees Pass Affordable Insulin Now Act It's Time to Provide Health Coverage Tax Credit Ask Senate Finance Committee Members to Approve S.1770 Enact Medicare Multi-Cancer Early Detection Screening Coverage Pass Retirement Security Bill

Employee Discount Programs

It has come to our attention that there is an AT&T Retiree Discount (Concession) document that can be read by clicking on an internet link.. While it references calling the AT&T Benefit Center for questions about your eligibility, Jane Banfield is available by telephone (908)268-5088, to help if more information is needed. For basic clarification, an excerpt from that document follows (on page 4 of our printed/hard copy newsletter).

For those of you who have internet access, questions about available Service discounts, contact and access can be answered by clicking on:

<u>Employee Discount Program Retired Employees Simple.pdf (att.com)</u>. For more detailed information on concession plans look under the WIRELINE & DSL section and click. You will get a 16 page document detailing what you are entitled to. Please note that each Operating Company had different benefits depending on when you retired. You will need to closely read through this document.

Employee Discount Program Page 2 of 19 Retired Employees

Your eligibility for a Wireline and DSL discount after you leave AT&T depends on your eligibility to participate in post-employment benefits and service availability at your primary home address.

You are eligible to participate in the Employee Discount Program (EDP) for retired employees if you satisfy the post-employment eligibility rule in your applicable comprehensive medical program or fall under a special separation provision of a bargaining contract or surplus agreement. Contact the AT&T Benefit Center (877-722-0020) if you have questions about your eligibility for post-employment benefits.

If you ARE eligible to participate in your applicable comprehensive medical program, you may be eligible to participate in certain Employee Discount Programs (EDPs) for retired employees. Your discount eligibility could be impacted by a number of factors, including your primary residence, Legacy Company and net credited service (NCS).

If you ARE NOT eligible to participate in your applicable comprehensive medical program, you are not eligible to participate in Employee Discount Programs (EDPs) for retired employees. The discounts you receive as an active employee will be removed from your account, and you will be charged consumer rates for products and services.

The discount you're eligible to receive depends on where you live and whether you retired as a management or bargained employee. Discounted service is only available at your primary home address on file with the AT&T Benefits Center.

You have to agree to the Terms & Conditions to participate in any discounts offered on Wireline and DSL through the Employee Discount Program.
